## RESERVATION POLICY

## Please familiarize yourself with our RESERVATION POLICY:

- Reservation requests are to be accompanied with our Visitor Registration and Credit Card Authorization Form in order to secure your Reservation.
- ★ Credit Cards will be processed once the Reservation has been confirmed by Island Yacht Club. Confirmations will be e-mailed
- **Each Reservation must be accompanied by Payment in Full (see rate sheet)**
- Specific Slip Assignments may be requested, and will be taken into consideration, however Island Yacht Club cannot guarantee requests
- Although Slip Assignments will be provided upon confirmation, Island Yacht Club reserves the right to change Slip Assignments without notice
- Prior to your arrival, please contact our Dock Master by calling 416-523-7666, or on VHF channel 68, for slip assignment confirmation and docking assistance, if required
- w Upon arrival, the Owner, or delegate, must sign in with the Dock Master or a member of our Staff

## **CANCELLATION POLICY**

In consideration of your Reservation being confirmed, we ask that you let us know if your plans to visit Island Yacht Club change or be subject to the following CANCELLATION POLICY.

Once your Reservation Date(s) is/are confirmed, Payment becomes subject to the following terms:

- Payments will be refunded in full if the Cancellation Request is received at least seven (7) days prior to the first day of the Scheduled Reservation Date
- If the Cancellation occurs six (6) to three (3) days prior to the first day of the Scheduled Reservation Date, an Administration Fee equal to 50% of the entire Reservation will be applicable
- There will be no refund if the Reservation is canceled seventy-two (72) hours, or less, prior to your Scheduled Arrival Date
- A Guest who does not cancel, and fails to arrive for their scheduled Reservation, will be charged 100% of their entire Reservation and the Reservation will be cancelled
- \* HOLIDAY WEEKENDS: Cancellations must be received two (2) weeks prior to the Scheduled Arrival Date. Failing which, the Payment will be forfeited and an Administration Fee equal to 100% of the entire Reservation will be applicable
- WEATHER POLICY: It is hard to know in advance what the weather will be like on the day of your visit.
